### **15. Terms and Condition for NOC:**

- 15.1 The organizers of the program will be held responsible for any violation of provisions of Protection & Maintenance Ordinance of Quaid-i-Azam Mausoleum.
- 15.2 That no speech will be allowed at Quaid's Mausoleum or within 10 feet distance from the grilled boundary wall of the Mausoleum.
- 15.3 The Program is allowed for Bagh-e-Quaid-i-Azam only.
- 15.4 Any damage to the Mazar Property will have to be made good by the sponsors/organizers.
- 15.5 The organizer will be responsible for coordination with the concerned police authorities (Traffic & Area Police) for law and order and other traffic problems.
- 15.6 The sponsors/ organizer will make their own arrangement regarding electricity connection from M/s. KESC Authorities.
- 15.7 The decision of the committee will be final and will be unchallengeable in the court of law.
- 15.8 The producer will submit one e-copy of the recording to the QMMB for its record.
- 15.9 The producer/director will ensure that no public movement is disturbed during the timing or recording.
- 15.10 Committee reserves the right to cancel any application without any reasons.
- 15.11 The NOC will automatically stand cancelled in case of breach of any of above condition.

### **16. Procedure for Grant of NOC:**

- 16.1 The Producer/ director of the program will submit an application and purchase an application form from the office of the Resident Engineer at Rs. 100/- per form and submit a detailed script of the program to be recorded in the premises of Bagh-i-Quaid-i-Azam at least 04 weeks before the date of actual recording.
- 16.2 Resident Engineer Quaid-i-Azam Mazar Management Board/ Secretary to the committee will convene a meeting of the within two weeks of receipt of application.
- 16.3 The producer/ director will give a presentation to the committee indicating relevance of the script and necessity of recording in Bagh-e-Quaid-i-Azam.
- 16.4 The committee after review will grant NOC to shoot the program subject to terms & condition mentions at para 15.
- 16.5 Resident Engineer. Quaid -i-Azam Mazar Management Board/ Secretary to the committee will give permission for shooting on behalf of the committee.
